Draft Minutes of the Support Committee of Western Quarterly Meeting held 28 September 2014 at Kennett Monthly Meeting

The Support Committee was held at Kennett Monthly Meeting. Friends from London Grove, Fallowfield, Kennett, Hockessin, West Grove, Newark, and Centre Meeting met to constitute the Support Committee.

14.41- After a period of un-programmed worship, Friends were welcomed to share news in the life of their Meetings London Grove 300th Anniversary on October 18th, 1-7 PM; West Grove is hosting an inter-faith dialogue speaker series during the month of October. London Britain Meeting House was recently vandalized. Hockessin hosted a presentation about the architecture and had a threshing session on the future vision of its tenant's house. On 10/27 Hockessin Friends will host a speaker from the Underground Railroad Coalition of Delaware on slave-catcher Thomas McCreary. Centre increased starting pay as they search for a coordinator for their First Day School program. Other general announcements from Monthly Meetings: September 30 week-- Religious Education Forum;, some Friends will be attending "Heeding God's Call" at Unitarian Universalism Church in Wilmington, DE on October 5th to advocate against gun violence. Some Friends already participated in rally in NE Wilmington against gun violence. Kennett is offering Quakerism 101 over eight months. Some members of Fallowfield attended an AFSC Program on the prison industrial complex and announced the local historical society wants to know what interest Fallowfield has in talking custodial responsibilities of People's Hall.

- 14.42- We approved the minutes of the WQ Meeting Support Committee Meeting held on 24 August 2014, with one correction. That correction relates to 14-37 to add "Fallowfield" to the sentence, "We discussed the desire for [Fallowfield] Monthly Meeting to take control of the Orthodox Fallowfield burial ground."
- 14.43- Friends agreed on Minute drafted for Fallowfield Monthly Meeting for hosting Western Quarterly Session. Minute reads: "We take this opportunity to minute our appreciation to Fallowfield Monthly Meeting in the hosting of the July 2014 session of Western Quarterly Meeting. It was a joy to be welcomed and brought into a space of close-knit community. The program was well matched to the theme, "Lighting the Fire Within." Utilizing segments of Quaker Speak and guided discussion opened the way for a deeper level of worship, sharing and introspection. Friends had the opportunity to feel their roots grow a bit deeper and open their arms a bit wider. We left this gathering with gratitude, feeling well nourished spiritually, socially and physically." - 14.45- **October Quarterly Meeting**. Reviewed schedule for the next Quarterly, "Ministry of Elderly Care" on October 19th. Friends agreed to meditate on Query #8 and provide a overview of the Western Quarterly website.

- 14.46- **Western Quarterly Meeting Coordinator Transition.** Friend Sarah Kastriner will continue to serve as Interim WQ Coordinator. The Personnel Committee of the WQ will present a report at the October 19th Quarterly about its recommendation for the position.
- 14.47- Responses from Monthly Meetings to Western Quarterly Letter Regarding Finances dated September 12, 2014. The consideration for each meeting is "to consider an increase in its financial commitment to the Quarter when it develops its next annual budget." London Grove and Fallowfield are discussing the letter at their next business meetings. Kennett is handling it in stages. Kennett uses unified budget. Financial discussions in Kennett center on a desire for transparency for why the numbers are what they are. Hockessin has not discussed it. Centre is just in the beginning of the budget year and we will receive updates from clerk when to discuss it. Newark will discuss it next year.
