Mill Creek - we are small and have a diversity of spiritual beliefs, we also have active vocal ministry and support each other in our own understanding of the spirit. We do monthly worship sharing of faith and practice. We feel grateful to have this place of worship. our historic meetinghouse has its own spirit of magic and spirituality. Our diversity of belief deepens our faith and we embrace those differences. We encourage sharing and we try to listen to each other and respect what is shared.

West Grove West Grove Monthly Meeting Query Answer for Second Quarter 2024

The Third Query on Spiritual Nurture was read. Sometimes messages create a ripple of interest in others and lead to other messages or discussion after Meeting. One Friend expressed thanks for the feeling of community in the Meeting. We help where we can when someone voices a problem.

Kennett - One responder replied that during the KMM Spiritual Retreat, we supported each other in our spiritual journeys and encouraged the use of spiritual practices that deepen our faith. She also noted the diversity of Spirituality practices in KMM which nurtures a richer spiritual experience.

Another replied that in KMM Adult discussions, we support each other in our spiritual journeys. Last month, discussion focused on verbal ministry.

The Clerk replied that in our meetings for worship there is a shared experience of Divine in which we nurture our collective spiritual growth.

One responder stated that today's letter from Jean Tennent illustrated the care and support that members experience as part of our Spiritual community.

Most of us faithfully attend meeting for worship, where we find that both the silence and spoken words appeal to us.

When our clerk asks us to hold a person in the light, because the person's health or another concern, this is deepening our spiritual practices. A Friend agrees that she finds that thinking of a person is a means of spiritual nurture.

Spiritual practices that another Friend finds helpful are:

- 1. Making a prayer list, because writing down the name down helps her bring that person to her
- consciousness, helping her to hold them close. Also, saying the person's name helps her bring power to this practice.
- 2. Walking her dog, for being outside in the earth and the nurture it provides is beneficial,
- 3. Connecting on the internet with QuakerSpeak and Friends Journal. One way we support each other and nourish our spirituality is with our Opportunity Fund. The fund provides financial assistance for participation in various opportunities for spiritual growth.

Part C asks about our relationship with life on earth, but a Friend notes that humanity is part of life on earth. She believes that the wording of this part of the query could be better, and that the words of the song "Simple Gifts" could help us "come down where we ought to be" by helping us include ourselves as a part of nature.

We support each other, and we accept each other's beliefs. We accept traditional Christians, people of the Jewish faith, Muslims, or individuals with no religious beliefs. Accepting everyone is part of allowing others their religious search. A Jewish Friend remarked that she always feels supported in our meeting. Another Friend has found that at any point of a difficult situation, she can call on someone from meeting who may have knowledge of that issue, and even if they don't have it, it's enough for her to know they will listen.

She also treasures the bluntness of one of our members, while appreciating all of us. She observes that we have no arguments, but some discussions. And for her, it's all good. She feels that's the divine.

London Britain Meetinghouse Annual Report for 2023

February, 2024

Friends held meetings for worship at the London Britain Meetinghouse this summer and early fall, with the exception of the Zoom monthly business meetings of Newark Monthly Meeting. The wearing of masks during meeting for worship was optional this year, although most Newark Friends continued to wear a mask during meeting. Weekly meetings for worship were held on Sundays from 10:30 to 11:30 am. The Wednesday evening meetings for worship held in previous years were not active in 2023.

An art show was held again at the London Britain Meetinghouse on August 13, 2023, in honor of Ruth Thompson of London Grove Meeting, since the show had been inactive for several years.

The business of the London Britain Property Committee was conducted by email in 2023, with the exception of one in-person meeting in November. The primary issues addressed were as follows:

Maintenance and repair:

- · Chris Horrocks completed the repair of the sash windows, and an east window frame this year. He also replaced gutter hangers and adjusted the front gutter so it would function properly.
- · Trish Norton constructed a new frame for the permanent sign at the London Britain Meetinghouse, because the previous sign frame had deteriorated.
- Lily Grosso redid the lettering on the permanent sign.
- · The grass was well maintained during the year.
- · Limited grounds work, such as weeding and tree pruning, was done by Friends and the mowing crew last year. We still don't have anyone engaged to provide this service.
- · Rickerman Tree Service removed a dead spruce tree in the NE corner of the property, and the dead tops of two trees near the north fence.
- Few Spotted lanternflies were seen on the property this year, so Lanternfly traps were not placed on the three red maples in front of the meetinghouse.
- · Tri State Pest Management, Inc. inspected the meetinghouse for insect pests, and found no problems.
- · A rented portable toilet was used instead of the composting toilet.

Graveyard:

- No plots in the London Britain Graveyard were purchased in 2023.
- The digital plot plan of the London Britain Graveyard was updated and corrected, following an inspection of the markers in the London Britain Graveyard, and some of the old images of headstones available in

https://www.findagrave.com/cemetery/2244049/london-britain-friends-burial-ground, in the winter of 2022. This updated plot plan was provided to The Friends Historical Library in Swarthmore.

We remain very careful in the management of the funds available for the graveyard and meetinghouse
