#### An Invitation from the Middle East Collaborative

Why DOES Palestine matter? An invitation to a 6 session course with members of the Middle East Collaborative—invitation by Deb Wood, Westtown MM, and Joan Broadfield Chester MM

As I thought about writing an invitation to the Why Palestine Matters course, I came across the following quotation, which fits the Palestine/Israel situation so well.

The purpose of propaganda is to make one set of people forget that other sets of people are human. — Aldous Huxley

The Palestine/Israeli relationship and conflict can often appear to be so complex and intractable that we don't know how we can ever understand enough to move forward. News coverage often comes without the entire context, so we can end up losing our ability to honor the humanity of all involved. When we stop seeing a person or group as human, we much more easily discount and discredit their experiences and humanity, and makes it much more easy to deny their needs and right to exist.

I think about the ways the US taxes fund the conflict. It's challenging to follow accurate ins and outs of Israeli politics, to follow Palestinian politics in the West Bank and Gaza, sift through: Is it or is it not occupation? Is it, or is it not, apartheid? Is it, or is it not, antisemitism? These questions deflect us from the basic simplicity of the situation.

When I look at this through my Quaker lens, through what value - that there is divinity in each person, which is cornerstone for testimony of equality, cornerstone for our peace testimony - I know that everyone deserves systems that center justice. So how can I stand aside when systems of injustice limit the existence of a people? What can we do to help remove the occasion for war?

It does not require in-depth knowledge on my part to recognize that advocating for a ceasefire is warranted, as we are now over 15 months into this current war. The number of Palestinian killed is over 40,000, and not all hostages have been freed. Settler violence against Palestinains in the West Bank has increased under the cover of the war; and the war has spread to neighboring countries, with international boundaries likely to shift. The resulting humanitarian crisis caused by war needs to be actively addressed, and so we advocate for peace, we advocate for justice.

To advocate for justice, it helps to understand more deeply why these two peoples lay such strong, (con't p. 4)


## A Tender Time: Quaker Voices on the End of Life

valid claims to the land. This can help our understanding as we recognize and sort through the propaganda- decades, centuries of propaganda about Arabs, Palestinians, and Jews. It will help to understand a fuller history of the middle east than we get from the news stories, and what we have been taught, often predominantly framed by western assumptions. Most of us have never truly learned about antisemitism what we learn about Zionism, antisemitism even apartheid.

To learn more, the stories we hear must come from more than our schools' history books and more than our mainstream journalism. The stories of the people themselves are important. Hearing ideas like apartheid applied to Israel may be shocking, but let's remember that President Carter wrote a book about this in 2006. Even Jews have been and are speaking about this, even some standing as refusers to the war. (Refusers Solidarity Network).

Why Palestine Matters is a collection of stories - of history, data, experience, and the thinking of a variety of people with the experience of the area and the knowledge of history with a Middle East lens. It is a curriculum that provides context for the challenges of Palestinian lives that have continued to be upended since the 1930s. It adds to our ability to address jus-

tice for Palestinians and safety for Israel—issues that have been very hard. The curriculum helps uncover the history of the land that has not been shared broadly.

Minutes - October 19, 2024 at Kendal

Friends were present from Kennett, Newark, Hockessin, Mill Creek, London Grove, Centre, and Kendal monthly meetings.

We opened with a period of worship to center ourselves for our work together.

#### Query Responses to the 9th Query

Mill Creek Friends Meeting Responses to the 9th Month Query —Grounding for Transformed Lives: Equality and Justice

How does our meeting benefit from established patterns of prejudice, exploitation, and economic convenience? What are we doing to change this?

We inherited the meetinghouse building and the surrounding property, and investment money that provides convenience and funds for its maintenance. We have enjoyed the benefits of education and generational wealth. However, we have added to our endowment with member contributions. We take loving care of the building and the property.

How and how often does our meeting engage in a self-examination of its attitudes and actions regarding race, ability, gender, sexual orientation or class?

We talk about the issue when we have our monthly Faith and Practice discussion and when discussing the queries. We come together to strengthen our connection to the spirit which also helps us to go out into the broader world and try to live in accordance with our testimonies.

What steps are we taking as a meeting to inform ourselves about social injustice and ecological violence embedded in our political and economic systems?

We don't do a lot as a group, but as individuals we try to stay informed and share things with the meeting to increase everyone's awareness of social injustice issues.

What steps are we taking as a meeting to assure that our meeting and the committees and institutions under our care are respectful of the earth and its people?

Because we are a small meeting, we don't have committees, nor do we have a school or nursing home facility under our care. But we are open to attenders and members regardless of their race, ability, gender, sexual orientation, or economic status. All are welcome. We are respectful of the earth and its people by limiting our use of natural resources. We also donate to the Food Bank periodically.

#### **New Garden Monthly Meeting**

The 9th Query was read on equality & justice. Our Meeting knows of no benefits to our Meeting from patterns of established exploitation. We keep our Meeting's investments with Friend's Fiduciary.

We do often self-examine our attitudes & hope that as individuals, we all are doing the right thing. A life-style of "simplicity" will help in our quest for respect of the earth and its people.

Failure to keep our youth educated of past history has been a terrible mistake. Without understanding the past, we are bound to repeat the mistakes of the past.

Our schools have chosen to condense history subjects to allow more time in the school day for math & science courses. This needs to change. Newark Monthly Meeting

The ninth query was considered by Aliza Appel, Ginny Bailey, Annemarie Carr, Gavin Ferris, Shelley Hastings, Diane Kesler, Lily Grosso, Maggie Ladd, Ariana Langford, Mike McDowell, Trebs Thompson, Treba Thompson, and Wayne Thompson.

A Friend commented that she likes this query a lot, and that she thinks it speaks to the very essence of being a Quaker and of "answering that of God in everyone," even people very different from ourselves. She also added that the care of the earth is very important to her, especially with climate change. She is finding it hard to find places to shop which aren't contributing to environmental problems. We're being distracted from these issues by politicians, she says. Another Friend said her week has been very full, including a Zoom international meeting. She learned that the Swedish government was sued by climate activists for not protecting the climate. She says she can also have a voice by choosing solar power and getting a programmable thermostat. She noted that the Kendal at Longwood retirement community is thinking about how to build for tomorrow in an environmentally responsible way.

A Friend observed that the amount of energy used by some things we do is drop in the bucket, compared to the space program, planes, and other major consumers of energy.

Responding to part b of this query concerning attitudes and actions regarding ability, a Friend recalled offering to help a man in a wheelchair to reach something on the top shelf in a store. He wasn't sure if she could do it because she's short. However, she was able to help. She found that in this case, concern about someone else's ability went both ways. She also shared that, when driving, she often thinks about what it would be like if she were black. She's aware that there is a privilege in driving to meeting as a white person. Another Friend met a black woman with a PhD who confronts prejudice every day. The woman she met is afraid to put out a Harris presidential campaign sign. The Friend also commented that she doesn't know if this query holds our meeting accountable enough for the things we should be

One Friend loved all of our responses to this query. She says that she responds to that of God in everyone. However, she recalled, with humor, that the head of the Friends Hospital was quoted in the Philadelphia Inquirer, saying he finds it hard to find that of God in some people, that maybe it is in their nails. She finished her response by saying that "It's all in a matter of everyday living, and finding the joy."

People are finding joy in responding to challenges, and we can find joy in ways to respond in a positive response.

#### Kennett Monthly Meeting.

One member replied that KMM is most active and effective with immigration support (political and economic systems). We ebb and flow into race issues, FFIS is the most effective action. Another member reports that he watched a documentary on Quakerism where a story was told about Quakers laying down in front of a bank due to their investment in fossil fuels. Their action brought about economic change and Quakers could instead invest in Friends Fiduciary which does NOT invest in fossil Fuel industry. His second response focused on self-examination of actions regarding ability, race, and gender, describing his family experience with neurodiverse people. He believes that children are also a class

that needs a voice and should be heard. He told his daughter that she can share her voice with PYM to describe what is needed by children in response to a query sent by PYM. He appreciates that he can worship with those who want to be inclusive.

Another member stated that Friends excel at self examination and appreciates that friends are talking to their families regarding self examination. He wishes there was more self examination in the public, noting that it is almost as if some people are proud of their ignorznce. He believes that if there was more self examination among people, maybe our society would be more willing to examine social and economic inequities. One member replied that the Hadley fund support of community / cultural programs is an example of how KMM supports efforts that address social and ecological injustice.

**Treasurer's Report** - see attached for full report; the coordinator shared the Highlights <u>Highlights:</u>

We are 25% through the fiscal year, and have received 28% of contributions toward our budget, and have spent 22% of our budgeted expenses.

-Most of the WQM funds are now held in a High Yield Savings account at Citadel, earning 4.16% interest. This has generated \$571.74 of income so far this fiscal year. (This is very good and in line with our budget estimates).

-One of the meetings in the Quarter has contributed an extra \$1000 towards the Coordinator's salary for FY25. (Deb's hours were reduced for FY25 in order to balance the budget. With this contribution her salary is increased to just under the original 21 hours a week level.) The budget has been updated to reflect this increased salary. -A few individuals donated \$170 to make up the projected shortfall (\$170 deficit) in the FY25 budget. We now have a balanced budget with a \$0 surplus/deficit. The budget has been updated to reflect this donation and reflect the balanced budget.

-A couple of meetings have increased their contributions for FY25 above amounts given for FY24 based upon the discussions at July Quarterly Meeting concerning the need to increase contributions towards WQM's annual budget. Any monthly meetings that have not yet approved their covenant for FY25 and are able to do so are asked to consider an increase in their contribution towards Western Quarterly Meeting.

#### **Update on California Heritage Indigenous Resource Center -**

At our last meeting for business Newark Monthly Meeting shared their minute and financial contribution in support of a land transfer.

Here is an update on the initiative:

The California Heritage: Indigenous Research Project (CHIRP) and the College Park Friends Educational Association (CPFEA) AKA Woolman are deeply proud to announce their successful endeavor to transfer 232 acres and the site of the John Woolman School into the hands of CHIRP and the Nevada City Rancheria (NCR) Nisenan Tribe. The escrow completed on September 27, 2024 and was the result of significant and inspired effort of all parties. The land, located on the historic Nisenan village site of Yulića, will once again become a landbase for the Tribe-and provides an opportunity for the NCR Nisenan Tribe to reclaim a piece of their land-based ceremonial and Cultural practices, Elder housing, and renewal of the Tribe's relationship with their Ancestral Homelands and its more-than-human kin. It is hoped that by once again having land the tribe will be able to regain federal recognition.

**Historic Properties Update** - the following minute is to meet a request to Philadelphia Yearly lor to see if she can do a program on January 19, Meeting for a written request of assistance. In case Western Quarter or one of its monthly meetings needs to repurpose or sell physical assets, we wanted to have some guidance on the practical and legal steps involved. We read and <u>Friends</u> approved the following minute.

Western Quarterly Meeting seeks the assistance of Philadelphia Yearly Meeting to understand the legal and practical to-dos involved in the laying down of a meeting and the selling of meeting property.

#### Background:

Western Quarter consists of 10 monthly meetings and one worship group in western Chester County, PA and New Castle County, DE. The Quarter has eight active meeting houses, six historic meeting houses, five support buildings, and eighteen burial grounds under the care of the Quarter or one of its Monthly Meetings. While we London Grove so will step back from these roles are not actively in the process of laying down a meeting or selling property, we want to be knowledgeable about the process in case circumstances

change. We do expect that to care for the perpetual commitments for burial grounds under our collective care, we may need to repurpose or sell some of the properties in our care. We are not well-versed with the legal and practical to-dos of selling or repurposing the property of a religious organization, and the implications of some properties being on a variety of historic registers. We do not want to create additional challenges for Friends and neighbors by missing or misunderstanding needed steps.

We have found the *Life Cycle of Meetings work* of Emily Provance of great help in the spiritual side of this work.

Task: the coordinator will send the minute to yearly meeting leadership and staff the week of October 21.

#### OM changes –

1) Host for January: we need a host or shall we Zoom?

We do have ideas for a program that could easily be virtual or hybrid. Kennett offered to provide a facility if others did the program and hosting. Friends agreed to a brown bag lunch for the day. The coordinator will work with tonya thames tay-2025 about her Civil Rights/Freedom Trail tour or about AFSC programs. Friends expressed interest in the Freedom Trail and thought it could be a wonderful public program.

We will move the April 20, 2025 quarterly meeting date to April 27 in order to avoid Easter. Mill Creek Meeting looks forward to hosting.

#### **PYM Nominating Council minute** - Approved.

Friends approve the voluntary service of the coordinator, Deb Wood, as a representative of Western Quarterly Meeting on the Nominating Council of Philadelphia Yearly Meeting.

#### **Western Quarter nominating need - audi**tor/assistant treasurer

Bob Frye has served for several years as auditor and assistant treasurer. He is the rising clerk for for Western Quarter. He has set up the work of an auditor to be done periodically across the year. The assistant treasurer's primary responsibility is

to help gather data to draft the budget in May and early June.

#### **Invitation from Kennett - additional Education Grant**

The Samuel Martin Trust of Kennett Monthly Meeting awards grants to families of children attending Quaker schools in pre-school through grade twelve who are in need of financial assistance. The awarded funds are to support academic programs. We would like to cast a wider net and invite families in Western Quaker to apply. Their application will be gladly received and considered if there are any funds available after grants have been awarded to active members and attenders of Kennett Monthly Meeting, and if they have applied and qualified for financial assistance from the School. Friends were curious to hear if meetings in the quarter had established a climate steward at their meetings. It was one of the queries to respond to in the recent state of the meeting report. Several meetings shared the climate related work they did, but none present spoke to having identified a climate steward.
